Currently, members of the public can attend parish meetings by Zoom but councillors cannot. It is predicted that in the future some form of hybrid meeting will be allowed. PC needs to future proof against this by buying the required technology for the pavilion meeting room using the government start up grant we have received. Technology may not get that much use initially but will serve as a business centre which the PC could perhaps hire out for meetings. Have taken advise from Adrian Waller who is very knowledgeable on such matters

Cllr Crossley **proposed** we purchase the required equipment subject to a **£1500** net ceiling, **seconded** by Cllr Shorthose and **agreed** by all.
